The HIPH Board has issued a number of letters concerning many important and priority matters regarding the activities of the Association's member companies including to:

- The Minister of the Environment, The Minister of Entrepreneurship and Technology, and MEPs; EUROFER's position letter on "Strategy for long-term greenhouse gas emission reduction in the EU a ground-breaking legal framework for low-carbon steel", which describes in detail the necessary policy measures for successful transformation. This is an action necessary for the EU to meet the ambitious climate goals it has set for 2050. To achieve this, the long-term EU strategy to reduce greenhouse gas emissions cannot only identify and mobilize investments from public and private sources to carry out R & Da tasks on the level of demonstration, scale-up and commercialization of breakthrough technologies, but also to ensure global competitiveness of our industry 06.02.2019;
- The Ministry of Environment, submitting comments to the draft regulation of the Minister of the Environment of February 1, 2019 on specific requirements for waste storage 18.02.2019;
- The Minister of Maritime Economy and Inland Navigation, the Minister of Entrepreneurship and Technology, sending a letter regarding the potential use of the national steel industry in the context of large investment projects coordinated by the Ministry of Maritime Economy and Inland Shipping with a request for a meeting with the steel industry in the Ministry 22.02.2019;
- The Ministry of Environment, sending a joint intervention of the Forum of Electricity and Gas Buyers FOEEiG and the Metallurgical Chamber of Industry and Commerce HIPH , to request considering the amendment to the Waste Act and implementing acts, including draft regulations and amendments

- to the provisions regarding obligations of: video monitoring, security bonds, fire-fighting protection, shortening the storage period, technical requirements for storage areas 26.02.2019;
- The Ministry of Energy, sending comments of the steel community as part of public consultations on the draft act amending the act on renewable energy sources and some other acts (UD477) 06.03.2019;
- co-signing by HIPH, together with other European companies and organizations, of the Joint Call to the Heads of State: "Let's Put Industry at the Core of the EU's Future!" 07.03.2019;
- MEPs, a request to take into account the comments of the steel industry during the vote of the ENVI Committee on the establishment of a framework to facilitate sustainable investment (the so-called "Taxonomy"), which is considered a valuable tool in mobilizing investment in the EU to achieve a sustainable transition to a low-carbon economy, 11.03.2019;
- The Head of the National Fiscal Administration at the Ministry of Finance, and the Minister of Enterprise and Technology, sending letters regarding the safeguarding measures imposed by the European Commission on the importation of steel products from third countries. Attention was sought to the real threat of circumvention and uncontrollable bringing in of steel products to the European Union market. Suggestion was made that new negative developments could be expected such as violations of regulations regarding origin, classification of goods, etc. Indication was made that the greatest threat to domestic producers may involve such steel products as: pipes and tubes, reinforcing bars, wire rod, hollow sections, HRC and CRC 14.03.2019;
- The Minister of the Environment with a copy to the Prime Minister, the Minister of Entrepreneurship and Technology, and the Minister of Energy, proposing amendments to the provisions on waste and environmental protection to ensure their efficient and effective focus on fraud control while ensuring respect for the principle of proportionality in the application of these provisions by law-abiding enterprises 29.03.2019;
- The Environment Committee and the National Economy and Innovation Committee of the Senate of the Republic of Poland; a request to allow the participation of HIPH representatives in the joint Committees session on April 11, 2019, to discuss the "Impact of the Waste Act on the Operating Conditions of Industrial Plants in Poland" 09.04.2019;
- The Ministry of Entrepreneurship and Technology (Industrial Policy Department, Innovations Department); requesting the organization of a working meeting to



discuss further steps related to the notification of the capacity market relief in the context of the European Commission decision on the capacity market relief - 19.04. 2019;

- The Ministry of Entrepreneurship and Technology, sending the position of HIPH regarding the draft bill on amending the Waste Act and the Environmental Protection Law together with the list of waste codes of non-flammable properties for the steel sector -30.04.2019r.

HIPH Council Session

19.03.2019 saw a meeting of the HIPH Council held at the premises of the Polish Steel Association. At the meeting, the Supervisory Board members were updated on the current steel, coke and refractory market performances as well as topics related to trade defense instruments (TDI), ongoing safeguard proceedings and applicable AD/AS duties.

The Council also became acquainted with the plan of activities undertaken by the Polish Steel Association within the framework of the formed coalitions: Working Group for Energy-Intensive Industries, issues covered by the cooperation with EY, and with FOEEiG and CO2 Forum.

HIPH conference

On March 21-22, 2019 a conference of HIPH Member Companies took place in Ustroń. At the beginning of the meeting, the representative of the Ministry of Enterprise and Technology presented the current status of safeguarding proceedings and trade defence measures in international trade in steel products and discussed the reasons for implementation and monitoring methods within EU steel market defence measures. Subsequently, the following issues were discussed: situation on the steel, coke and refractory markets, trade in EU steel products with third countries. The current state of trade defence proceedings and measures in place in the international trade in steel products and raw materials for steel making was presented. Current topics were also discussed of importance to steel producers in Poland and in the EU.
