The HIPH Board has issued a number of letters concerning many important and priority matters regarding the activities of the Association's member companies including to:

- Ministry of Environment, Mr M Kurtyka, Secretary of State in the Ministry of Environment, Commissioner of the Internal Market, Industry, Entrepreneurship and SMEs, Ms E Bieńkowska, Permanent Representation of the Republic of Poland to the EU, regarding the post-2020 free allocation rules for emission allowances which are an important element of the entire regulations preventing the carbon leakage and maintaining the competitiveness of the steel sector 12.07.2018;
- Energy Regulatory Office URE, with a request for providing public information regarding the public aid scheme specified in the Act of 29.06.2007 on principles of covering costs incurred by power generators in connection with the early termination of long-term power and electricity sales contracts (LTC Act) 07.08.2018, to Zarządca Rozliczeń S.A. 10.08.2018, to PSE S.A. 23.08.2018;
- Minister of Environment, regarding the draft regulation on the rates of securing waste claims 16.08.2018;
- Ministry of Energy, Mr G Tobiszowski, Secretary of State in the MoE, with comments on the draft Act amending the Energy Law Act and certain other acts 17.08.2018;
- Minister of Environment, HIPH together with IGMNiR and IPHGZ, with an appeal for the amendment of the Waste Act 29.08. 2018;

HIPH Council Session

24.09.2018 saw a meeting of the HIPH Council held at the premises of the Polish Steel Association. At the meeting, the Supervisory Board members were updated on the current steel, coke and refractory market performances as well as topics related to trade defense instruments (TDI), ongoing safeguard proceedings and applicable AD/AS duties. There was also a discussion about the ongoing "trade war" after the US decision to impose a 25% duty on steel imports and the introduction by the EU of provisional tariff rate quotas (for 200 days) for steel imports. The Council also became acquainted with the plan of activities undertaken by the Polish Steel Association within the framework of the formed coalitions: Working Group for Energy-Intensive Industries, issues covered by the cooperation with EY, and with FOEEiG and CO2 Forum.

Information meeting HIPH

July 9, 2018 saw at the premises of HIPH, the Board having organised together with the Ministerial Unit EU Proceedings and Trade Defence Measures in the Department of International Cooperation at the Ministry of Enterprise and Technology, an information meeting on the implementation of measures to protect the Polish steel market following the introduction of steel tariffs by the United States (Section 232).



HIPH conference

On September 13-14, 2018 a conference of HIPH Member Companies was held at Ustroń. During the meeting, the following issues were discussed: steel, coke and refractory markets performances, EU steel trade with third countries. The current state of safeguard and ongoing trade defence measures in international trade in steel products and raw materials for metallurgy was presented. Current topics were also discussed, of importance to steel producers in Poland and in the EU.

New Industry Expo Event

On September 27-28, 2018, New Industry Expo event took place in Katowice. On the first day the President of the Board of the Chamber took an active part in the panel discussions on: Energy Market in Poland and Climate Policy - What Will COP24 in Katowice Bring? The President of the Board of the Polish Steel Association appealed to the power industry to take note of how the steel sector, the great consumer of energy, is affected. He stressed that steel making plants are the benchmark facilities and the most modern in the world, and yet the steel industry is losing out in Europe, mainly due to the cost of electricity.

On the second day the steel industry panel was held debating on, among others, the following topics:

- Overview of New Technologies and Solutions to Reduce Costs and Better Use of Resource
