HIPH Council Session

At the meeting on June 6, 2019, the Council adopted the agenda of the General Assembly Meeting without reservations and adopted Resolutions regarding approval of the reports of the Management Board and of the Council, financial statements for 2018, adoption of the plan of activities and estimates of expenditures for 2019, and approved the principles of financing the Chamber in 2019.

HIPH General Assembly

June 6, 2019 saw the 33rd General Assembly of the Members of the Polish Steel Association HIPH held at the headquarters of HIPH. The General Assembly was of a reporting and electoral nature.

In a secret ballot, Mr Stefan Dzienniak was unanimously elected president for the next term of the Chamber's Board. The 9-person Chamber Council was also appointed. The participants of the General Assembly were unanimous and agreed that HIPH, thanks to its activities, was an unquestionable representative of the iron and steel community both on the regional and national forums.

HIPH conference

June 6-7, 2019 saw a HIPH Conference of Member Companies taking place at Ustroń. At the beginning of the meeting, the representative of the Ministry of Entrepreneurship and Technology presented the current state of trade defence measures and proceedings in international steel trade and discussed the reasons for implementation and methods of monitoring EU steel market defence measures. Subsequently, the following issues were discussed: steel, coke and refractory market developments, EU steel trade with third countries. The current state of defence measures in international steel and raw materials trades was presented. Current topics were also discussed of importance to steel producers in Poland and in the EU.
